ALLOTMENT AND ISSUE OF SHARES PURSUANT TO EXERCISE OF WARRANTS

The Board of Directors of ASL Marine Holdings Ltd. (the "Company") wishes to announce that the number of issued ordinary shares of the Company has increased from 919,701,801 ordinary shares to 937,716,451 ordinary shares (inclusive treasury shares of 2,511,600) following the allotment and issue of 18,014,650 new ordinary shares in the capital of the Company (the "New Shares") pursuant to the exercise of 18,014,650 warrants at the exercise price of S\$0.06 per share, on 15 July 2024.
